The body is transferred to the funeral home from within a 30-mile radius, places in refrigeration until the necessary AUTHORIZATIONS and permits are obtained, places in a cardboard cremation container required by the crematory and delivered to the crematory. The body is cremated, and the cremated remains are then returned to the funeral home for return to the family. There is no public viewing or ceremony.
